Addictions & Mental Health Worker or Registered Practical Nurse (RPN) – Developmental Disabilities Service (DDS)

The Canadian Mental Health Association – Cochrane Timiskaming Branch is currently recruiting an Addictions & Mental Health Worker (A&MHW) or Registered Practical Nurse (RPN) – Developmental Disabilities Service (DDS), in New Liskeard.

DDS is a regional program of the North Bay Regional Health Centre (NBRHC) and is a partnership between NBRHC and CMHA Cochrane Timiskaming Branch (CMHA-CT). In keeping with the Mission, Vision, Values of the CMHA-CT, the employee works within an interdisciplinary team to provide service coordination between DDS outreach and the local hospital as well as the NBRHC in-patient unit.

Developmental Disabilities Service (DDS) provides community based psychiatric assessment, consultation and treatment for adults with developmental disabilities and mental health needs (dual diagnosis) within the district of Cochrane (Timiskaming). Our goal is to support mental health and recovery, improve quality of life, and prevent unnecessary hospital stays. The employee works with individuals, families, family doctors, and the DDS team in the client's community and home. Care is provided with a client and family centred approach and considers physical, mental health needs and any problems in their home or life.

Qualifications:

- Registered Practical Nurse Diploma with current certificate of registration in good standing with the College of Nurses of Ontario. OR
- A Bachelor's Degree in Social Work or a Bachelor of Arts degree in one of the core mental health disciplines is preferred. Registration with the Ontario College of Social Workers and Social Service Workers would be an asset; (Other levels of relevant education with experience in mental health may be considered)
- Knowledge of the Mental Health Act;

- Knowledge and application of best practices in caring for those with a dual diagnosis (including working knowledge of current practices in pharmacotherapy in dual diagnosis, skills in behavioural assessment and recovery/support plans)
